## LANDOWNERS LEARN ABOUT LEACH XPRESS DURING OPEN HOUSE MEETINGS

In November, Columbia Gas Transmission hosted a series of open house meetings to inform landowners, residents and local officials about the proposed Leach XPress pipeline project, which will originate in the West Virginia panhandle and travel through several counties in southeastern Ohio.

More than 250 attended the open houses, which were held in Hocking, Jackson, Monroe and Noble counties in Ohio and Marshall and Wayne counties in West Virginia. The meetings provided attendees an opportunity to meet with representatives from Columbia's engineering, land, natural resources permitting, pipeline construction and operations teams and to ask questions about the project.

"Open, transparent communication, particularly with landowners, is extremely important," said Zane Daniels, manager of community relations and stakeholder outreach for Columbia. "These meetings provided a valuable opportunity for us to interact with landowners and address their individual concerns."

Landowners also had the opportunity to meet with representatives from the Federal Energy Regulatory Commission (FERC), the primary regulatory body overseeing the proposed interstate pipeline project. FERC will conduct a comprehensive environmental review of the project as part of the approval process.

The Leach XPress project will be designed, constructed, and maintained in strict compliance with U.S. Department of Transportation safety requirements. The new facilities will be protected by underground pipeline corrosion prevention systems, performance monitoring by trained personnel in our Charleston, W. Va. Monitoring Center, and periodic aerial patrols of the pipeline right-of-way to look for conditions in the field that could impact pipeline operations.

In addition, we will conduct interior pipeline inspections with advanced tools called "smart pigs" to study the integrity of the pipeline and identify any areas in need of repair.

#### 24/7 SAFETY MONITORING

To ensure around-the-clock pipeline safety and integrity, Columbia operates several Gas Control Monitoring Centers throughout its operating system. At these centers, highly trained employees gather and analyze data transmitted from pipelines and related facilities. This data allows them to quickly identify and respond to potential issues and adjust gas flow if necessary.

#### PARTNERING WITH EMERGENCY RESPONDERS & COMMUNITIES

We view emergency responders who serve communities within the Leach project footprint as part of our expanded safety team. We look forward to providing training and expertise to help prepare them for any contingency. We will also continue to educate landowners, contractors, excavators and local officials about how to prevent, detect and report possible leaks along our pipeline system.
